For more than four decades, we've had the privilege of walking alongside thousands of givers to guide them through the complicated landscape of giving.

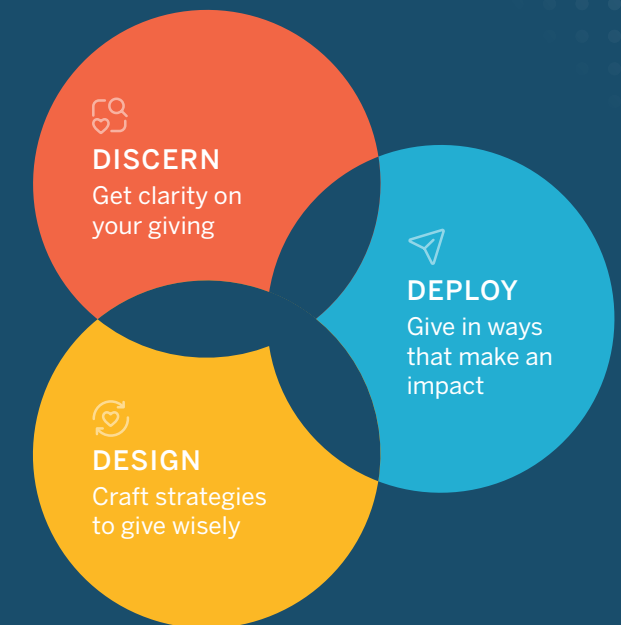
